A few people have asked me for more information regard the fraud charges raised last week against one of our former employees, Mr. Joe Meisch. He was employed by St. Patrick's from March, 2013 to July, 2018. He was not initially hired as the business manager, but over time he learned the role from the then-business manager and seemed to be well suited for the position. He then took over the job when the previous business manager had to move out of state. Fr. Klores was very trusting toward Mr. Meisch, and he showed himself to be very competent in his duties. He served as business manager from June, 2016 until his resignation in July, 2018.

Soon after Fr. Bozant arrived, there was an audit of the parish by the Archdiocese. These audits are carried out roughly every three years. During that process, serious irregularities were discovered and Fr. Klores confronted Mr. Meisch about them. Mr. Meisch immediately resigned. Consulting with the legal personnel at the Archdiocese, it was decided to turn the matter over to investigators. The investigation was initiated prior to my arrival as pastor. From that time until last week, the US Attorney's office and the investigators were working to define the charges and specify the amount of our loss.

Even though the process was taking a long time to unfold, I continued to remain in touch with the Archdiocese about how our parish could best recover from this trauma. I was asked to protect the investigation process by keeping the proceedings confidential. At the same time, we were able to share details with our parish staff and Finance Council. We were also able to submit an "employee dishonesty" claim with the Archdiocese who is self-insured against losses of this kind. We were granted the maximum compensation amount allowed by our policy of \$125,000. This I reported to the parish in the bulletin of January 19 and in this past annual financial report.

After Mr. Meisch's resignation, some immediate changes were made to our accounting procedures. First, the accounting assistance program offered by the Archdiocese was employed to aid Fr. Klores and Fr. Bozant in reorganizing the parish financial operations. Mrs. Jan Merington was hired to restore order to the files and implement all the advice of the parish auditors. A new money counting team was recruited and better controls on the movement of collection funds was put in place, including the funds donated online. Now, each expenditure of parish funds is personally approved by me. Any reimbursements that are due to me are approved by Deacon Digrado. We no longer keep a "petty cash" on hand, and prior approval is needed before anyone uses a parish credit card. While parish finances are not the property of the Archdiocese, our finances are computerized and can be reviewed by the appropriate Archdiocesan personnel. Some new members were added to the Finance Council and I have asked them to be more involved in setting our budget, as well as reviewing our statements. Soon, we will also be exploring ways for the Finance Council to carry out regular internal audits. I am told by the US Attorney's office that, as the court case concludes, the judge will determine whether and how much restitution will be granted to the parish by the perpetrator. I fully intend to keep our parish informed as the case progresses.

The above is a very brief summary of over two years worth of effort to "right the ship" here at St. Patrick's. I can understand if some parishioners feel uncomfortable that information was hidden for a time. Upon the advice of legal professionals and the deliberations of the Finance Council, we decided it was necessary to be exceedingly prudent in what we shared in order to prevent any obstacle to the investigation. I know how important it is to have accountability and transparency in financial matters, and I will continue to foster these. The many ways that parishioners support our churches is a genuine sign of love and fidelity to God. As such, I consider all contributions (financial and otherwise) as sacred—each of them imposes on me the responsibility of prudence and accountability.

As I mentioned in my announcement last week, our healing process may still take some time. Bet even in this, we have the opportunity to exercise great love in the midst of our suffering. I truly consider it a God-given privilege to be your pastor. Since becoming pastor, I quickly learned of the admirable commitment and generosity of our parishioners. Therefore, with great hope, I look forward to continuing our mission of building the Kingdom of God. ~ Fr. O'Brien
